**Subj.: Adoption of 300 days' upper limit of accumulation of earned leave and simultaneously considering the leave account (earned leave/half-pay leave) to be a continuous procedure during movement from one college to another, on leave with lien or otherwise, for the regular whole-time teachers and Principals in substantive positions of affiliated colleges, other than Govt. Colleges.**

It is notified for information of all concerned that in compliance of the orders from the Dept. of Higher Education, Govt. of W. Bengal, vide (a) G.O. No. 762-Edn(CS)/2L-10/08, dt.- 03/12/2009 [issued with concurrence of Finance Dept.,GoWB, vide their U.O. No. 4095 Group-P(Service), dt.- 02/12/2009] read with (b) G.O. No. 163-Edn(CS)/2L-10/08, dt.- 17/02/2011 [issued with concurrence of Finance Dept.,GoWB, vide their U.O. No. 609 Group-P(Service), dt.- 17/02/2011] and (c) Amendment G.O. No. 972-Edn(CS)/2L-24/13, dt.- 20/12/2013 and in exercise of the provisions of sections 21(i), 21(xiii), 45(i) and 46 of the Kalyani University Act, 1981 the 9<sup>th</sup> Executive Council of the University of Kalyani in its 6<sup>th</sup> meeting held on March 10, 2017 has decided (vide item No. 19 of the Agenda) that for the regular whole-time teachers and Principals in substantive positions in the affiliated colleges, other than Govt. Colleges, under the University –

- (i) *the upper limit of accumulation of earned leave shall be 300 (three hundred) days [vide Para 12(B)(ii) and Para 15 of G.O. No. 762-Edn(CS)], and*
- (ii) *when a teacher moves from one college to another on leave with lien or otherwise, his/her accumulation of earned leave/half-pay leave in the new college will be as per previous accumulation of leave, i.e., in other words his/her leave account will be a continuous procedure [vide Para 12(B)(v) of G.O. No. 762-Edn(CS)].*

The nitty-gritty of extending the above benefits will follow the modalities, terms and conditions as detailed in the above mentioned government orders.

This notification will take retrospective effect from 03/12/2009 [i.e., date of issue of G.O. No. 762-Edn(CS)/2L-10/08] pending amendment in the Statutes which will be done in due course.
