It is notified for information of all concerned that in compliance of the order issued by the Govt. of W. Bengal, vide (a) G.O. No. 08-ILC/OM-131L/15, dt.- 13/01/2016 read with (b) G.O. No. 309-ILC/OM-131L/2015, dt.- 22/09/2015 [issued with concurrence of Finance Dept., GoWB, vide their Memo No. 5560-F(P), dt. 17/07/2015 and 5780-F(P), dt. 29/07/2015] and (c) G.O. No. 274-ILC/OM-131L/15, dt.- 07/12/2016 and in exercise of the provisions of sections 21 (i), 21 (xiii), 45 (i) and 46 of the Kalyani University Act, 1981 the 9th Executive Council of the University of Kalyani in its 6th meeting held on March 10, 2017 has approved of (vide item No. 19 of the Agenda) the **introduction of grant of Child Care Leave (CCL) for a maximum period of 2 years, i.e., 730 days for the regular whole-time permanent female employees (both teaching and non-teaching) of all affiliated colleges, other than Govt. Colleges, under this University with effect from 13/01/2016.**


The nitty-gritty of extending the above benefit will follow the modalities, terms and conditions as detailed in the above mentioned government orders.
