Online E-Tender is invited for the purchase of **REAL TIME GRADIENT THERMAL CYCLER WITH ACCESSORIES & REFRIGERATED CENTRIFUGE WITH ACCESSORIES** for the **WB- DST FIST Sponsored Programme, Department of Microbiology, University of Kalyani** by the eligible vendors. Interested vendors may follow the instructions as given below for submission of their tenders under online mode:

**NAME OF THE INSTRUMENT: REAL TIME GRADIENT THERMAL CYCLER**

**(i) MAIN INSTRUMENT:**

- It should be an automated system for both real-time PCR and post-PCR (end-point) analysis using in-built Peltier based block with full license for PCR process.
- The system should be capable of applications such as Absolute quantitation; Simultaneous analysis of data for relative quantitation for 10 number of plates of 96 wells each; Multiplex-PCR minimum 4 targets, allelic discrimination (SNP), miRNA profiling, Dissociation curve analysis, Copy number variation, Pathogen detection and plus/minus assay using internal positive control. The normalization of reaction due to non-PCR related fluctuations such as pipetting variations should be possible by using any calibrated dye.
- System should have in build thermal cycler that can create thermal gradient.
- Three independent Peltier Block to provide three independent temperature zones to run three different assays with varying annealing temperature at the same time.
- Each block having the ability to set up PCR with specific temperature differential of up to 5 degree centigrade between blocks and 25 Deg from one end to another.
- A Peltier based 96 × 0.2 ml well thermal cycle
- Standard transparent 96-well plates or individual transparent PCR tubes or 8 strip tubes compatibility.
- Temperature range of 4 °C-100 °C is essential.
- Maximum Block ramp rate of 6° C/Sec or more.
- Reaction volume 10-100 µL and should use Universal thermal cycling conditions.
- Run time of less than 30 minutes for 40 cycles in Fast Mode
- The System should be combined at least 4 coupled excitation and emission filter sets to enable collection of wavelengths during a single run for multiplexing on the 96-well block instrument.
- Dynamic range up to 10 orders of Magnitude.
- The instrument should include a heated lid assembly that heats the top half of the sample plates and provides an effective seal to minimize reaction mixture evaporation.
- System should include the following optics:

- a) The excitation by White LED light source with a > 5 years life span and detection by CCD/sCMOS
- b) System must collect data for all filters for all wells regardless of plate setup.
- c) System should be capable for detection of 10 dyes FAM™/SYBR® Green, VIC®/JOE™/HEX/TET, ABY®/NED™/TAMRA™/Cy®3, JUN®, ROX™/, Texas Red® dyes on a single plate.
- System should include the following software:
  - a) Integrated appropriate software that could be operated through external PC.
  - b) The data collection and instrument control software should provide multicomponenting algorithm for de convolution of multiple dye signal with minimum cross talk.
  - c) It should be possible to alter the plate setup after the completion of run.
  - d) System should have option like Stand-alone, PC connected, or direct connection to Cloud via LAN or Wi-F.
  - e) The instrument online software allows users to batch analyze up to 500 experiments simultaneously.
- System should enable the following chemistry:
  - a) System should be an open platform enabling use of various chemistries without hardware change.
  - b) It should be standardized for Taqman-MGB Probe based 5' Nuclease Assay and SYBR Green Chemistry, to be set-up on single plate with seamless switchover during the run.
  - c) Pre-validated and functionally tested Taqman Gene Expression Assays as well as Taqman SNP Genotyping Assays should be readily available.

### (i) MAIN INSTRUMENT:

- Relative centrifugal force (rcf) > 16000 x g
- Maximum Rotational Speed > 13,300 rpm
- Full digit display for ease of programming
- Should have low noise level < 50 dba
- Should have Acceleration/Deceleration control facility
- Time Set Range: 1 min - 99 min; 1 min increments + HOLD mode
- Temperature Range: Set from 0 °C to +40 °C per 1 °C increment
- Should maintain constant 4° C at max. speed.
- Should have function for rapid cooling of centrifuge
- Should have inbuilt condensation drain.
- Should have dynamic compressor control system to maintain temperature precisely
- Compressor should shut down automatically after non use of 7 to 9 hrs.

**1. General Instructions:**

In the event of e-tendering, intending bidder may download the tender documents from the website: <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate (DSC) or from the University of Kalyani's website [www.klyuniv.ac.in](http://www.klyuniv.ac.in).

**2. Submission of bids:**

Both Technical bid and Financial Bid are to be submitted concurrently duly digitally signed by the Company personnel who is in the pay roll of the Company (having Authorization from the Company management) in the website [http:// wbtenders.gov.in](http://wbtenders.gov.in). All papers must be submitted in English language.

**3. Time Schedules for the e-tender:**

The Time Schedule for obtaining the Bid Documents, Pre Bid meetings, the submission of bids and other documents etc. will be as per the list provided in Clause No. 10 given below.

**4. Eligibility for Quoting:**

Manufacturers or Dealers/Distributors/Agents duly authorised by the manufacturers who are able to supply the assured quantities as per requirement & have requisite Annual Average Turnover, as per clause no. 6, are only eligible for quoting. Manufacturers not having the capability to supply the required quantity solely need not apply. Failure of submission of declaration of full supply will lead to cancellation of tender.

Further, vendors who were declared black listed and/or insolvent by any Govt. Concern/any Institutions in the Country for particular item or items are not eligible to participate in the current tender for that item or items.

**5. Annual Turnover Requirements:**

Vender having average annual Turn Over for last three financial years is more than Rs.50 Lakh in India or equivalent foreign currency in the respective foreign country for the year **2013-14, 2014-15 & 2015-16** are eligible to participate in the Tender.

**6. Submission of Tenders**

**7.1 General process of submission**

Tenders are to be submitted online through the website stated in Clause 1. All the documents uploaded by the Tender Inviting Authority form an integral part of the contract. Tenderers are required to upload all the tender documents along with the other documents, as asked for in the tender, through the above website within the stipulated date and time as given in the Tender. Tenders are to be submitted in two folders at a time, one is Technical Bid and the other is Financial Bid .The tenderer shall carefully go through the documents and prepare the required documents and upload the scanned documents of originals in Portable Document Format (PDF) to the portal in the designated locations/folders of Technical Bid. He needs to fill up the BOQ in the designated cell and upload the same in designated location of Financial Bid. The documents uploaded are virus scanned and digitally signed using the Digital Signature Certificate (DSC). Tenderers should specially take note of all the addendum/corrigendum related to the tender till the bid submission ends. Tenderers should in general upload the latest documents as part of the tender, however, in case of failure in uploading such documents, it will be deemed that they (tenderers) have taken note of such latest documents including addendum/corrigendum, if published till the bid submission

ends.

### 7.3 Financial Bid

The Financial Bid should contain the following document in one cover (folder):

**Bill of Quantities (BOQ): The tenderer should fill-up the designated cell as marked by the University in the BOQ sheet.**

- The tenderers are not required to submit hard copies of Technical File (Statutory) or My documents (Non-Statutory). Submission of hard copy of Financial Bid is strictly prohibited and only be submitted through on line through NIC portal.

### 8. Evaluation of the tenders

During the tender evaluation process, the “Technical Bid” will be opened first. Those Bidders who have qualified in respect of the essential & other requirements in “Technical Bid” will be identified and their financial bid will be opened. The financial bid of those Tenderer failing to meet the technical & other requirements laid down in the tender will not be opened and be rejected. The Tenderer offering the item found suitable and as per the tender specifications will only be selected. Final selection of the lowest bidder in respect of Financial Bid is subject to further verification. The Financial Bids of only those tenderers who have been considered as Technically Qualified will be opened. If found suitable in the context of above pre qualification etc, the Tenderer quoting the lowest rate will be considered as successful.

### 9. TERMS & CONDITIONS REGARDING PURCHASE POLICY OF TENDERING AUTHORITY:

#### 9.1 Bid Information:

##### Bid Information:

- Bidder must quote in any Currency as given in the BOQ.**
- The rate quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- Bidder must follow the instruction for filling up BOQ as per Clause 7.3.**

- Evaluation of Quotation:** The Purchaser will evaluate and compare the quotations determined to be substantially responsive stage wise. Firstly, Technical Bid will be evaluated based on and thereafter Price Bid for technically qualified bidders will be evaluated for selection of vender.

- Award of Contract:** The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive both technically and commercially for both the equipments. Purchaser reserves the right to reject any or all the tender, wholly or partly, without assigning any reason thereof and shall not be bound to accept the lowest bid.

- Warranty:** The vendor shall be fully responsible for the comprehensive onsite warranty in all respect of the equipments, accessories etc. including spares and services for a period as per specification from the date of installation. Warranty will be effective from the date of joint installation Report.

9.5 **Adequate support service facility:** The bidder/manufacture should have adequate service support centre in Kolkata for any emergency breakdown/fault offering facility within 48 hours and should be agreeable to provide AMC facility after the warranty period.

9.6 **Training Facility:** User training regarding the operation of the equipments shall be arranged by the supplier/vendor at no extra cost.

9.7 **Manufacturer's Authorisation:** Document in support of Manufacturer/Dealer and Service Provider has to be submitted along with the tender paper. If the bidder is not the manufacturer, proper manufacturer's authorization and warranty from manufacturer is required and in this case bidder should have full- fledged registered office in India.

9.8 **Credentials:** Documents of supplying similar items in last two previous years in an Institute of Higher Learning must be submitted along with the tender.

9.9 **DSIR Certification:** University of Kalyani possesses the privilege for availing the facility of procuring items at Concessional Customs Duty and without incurring any excise duty as per DSIR certification.

9.10 **Make & Model:** Bidder must mention Make and Model in the Information Sheet as given vide Annexure-I and must send the product details/catalogue/brochure in the "Technical Details" folder.

9.11 **Time Schedule:** The supply and installation work must be completed within 30 days from the date of receipt of the purchase order.

9.12 **Validity of offer:** A bidder should spell out in the tender that it shall remain valid for a minimum period of three months from the date of opening of the tender and during this period, the bidder shall not be entitled to revoke or cancel its offer.

9.13 **Place of delivery:** Department of Microbiology, University of Kalyani, Kalyani -741235.

9.14 **Payment Schedule :** Payment be made after delivery and installation of the items.

9.15 **Performance Security:**

Successful bidder should deposit Performance Security money equivalent to the 10% of the order value in the form of DD/ suitable negotiable instruments as to be decided by the University immediately after issuing purchase order from the University. Such security will be refunded after completion of the warranty period in normal case without any accrued interest. University may forfeit the Security Money in the event of the following circumstances:

i) Selected bidder withdraws the bid before expiry of its validity but after receipt of the Purchase Order.

ii) Selected bidder does not accept the order after issuing the same or fails to enter into a contract within validity period of offer.

iii) Selected bidder fails to supply the items within the scheduled time as specified in the Purchase Order

iv) If before expiry of the warranty period, the supplied items break down or do not function satisfactorily due to the cause related with the item itself or for its installation and not for any reason caused by the University Authority and the supplier denies to take the responsibility to make the supplied items in order.

v) In case of any false submission /statement by the bidder

vi) In case of any refusal to abide by terms and conditions or refusal to enter into a written agreement as per prefixed terms and conditions

9.16 **Quantity Changeability:** Quantity as stated in the tender document may subject to change at the time of issuing purchase order due to the fund crunch or for other valid reasons.

9.17 **Requisite Documents to be submitted:** Bidder must have adequate documents relating to Trade License and updated returns for Income Tax, VAT, Audited Statement of Accounts and other documents as sought for under Clause 6.2.II of this tender.

9.18 **Turnover Criterion:** Bidder must have average annual turnover of more than **Rs.50** Lakh in three financial year ending 2015-16.

9.19 **Disposal of Disputes:** In case of any dispute, the University's decision will be treated as the final and conclusive. All legal actions are subject to Kolkata jurisdiction only.

9.20 **Conversion of FC Rate:** Generally, the West Bengal Government Portal is equipped enough for conversion of Foreign Currency (FC) rate into INR. In case of any problem arising out of the West Bengal Government Portal for e-tender regarding the conversion rate against foreign currencies quoted by the bidders in the BOQ, the conversion rate as existing in the official website of the Reserve Bank of India (RBI) as on the date of opening the Financial Bid will be considered for Financial Bid Evaluation.

**Discretion of the University:**

9.21 University may take decision about non-purchase of the said equipment even after selection of vendor due to its fund constraints.

9.22 University may seek documents from the bidder in addition to the scanned documents sent by them at the time of uploading technical bid for verification and evaluation of tender.

9.23 University reserves the right to relax any clause as stated hereinabove for selection of responsive vendor.

10. Opening the financial bid as per schedule will BE NOTIFIED LATER ON.

Financial bid can be seen & accessed by the bidder through the NIC Portal on line after opening of financial bid on line. No objections raised by any Bidder in this respect will be entertained by the University. No informal tender will be entertained in the Bid further.

11. During the scrutiny, if it comes to the notice to tender inviting authority that the credential or any other paper found incorrect/ manufactured/ fabricated, that bidder would not allowed to participate in the tender and that application will be rejected outright without any prejudice.

12. The Tender Selection Committee reserves to right to cancel the N.I.T. due to unavoidable Circumstances and no claim in this respect will be entertained.
